



**NOTICE TO MUNICIPAL ELECTORS IN THE
TOWNSHIP OF NORTH FRONTENAC
NOTICE OF REVISIONS TO THE VOTERS' LIST**

The Voters' List will be available for inspection in the Municipal Office during the period Tuesday, September 7, 2010 until Monday, October 25, 2010 at 8:00 p.m. Electors should examine the list to ensure their name and relevant information is correctly shown. Application for inclusions, additions or corrections to, or deletions from the List may be made by an Elector by completing and filing an Application Form, available at the Municipal Office and/or on the Municipal website. The Application shall be in writing and shall be filed:

- a) in person by the applicant or his or her agent; or
- b) by mail, by the applicant (certified copy of identification enclosed).

IDENTIFICATION IS REQUIRED from any person requesting a revision to the Voters' List. Contact the Clerk to determine what forms of identification are acceptable. If a person whose name is on the List does not have identification or the identification provided is not acceptable, then the Voter will be required to complete a Declaration of Identity Form. Any Voter not on the List must have acceptable identification; otherwise, they will be unable to vote.

During the period beginning Tuesday, September 7, 2010 and ending on Nomination Day (September 10th, 2010 at 2 p.m.), a person may make Application to the Clerk requesting that another person's name be removed from the Voters' List. The application shall be in writing and shall be filed:

- a) in person, by the applicant or his or her agent; or
- b) by mail, by the applicant (certified copy of identification enclosed).

Revisions to the Voters' List will be undertaken from Tuesday, September 7th to Friday, October 22nd, 2010 during normal office hours and Monday, October 25, 2010 until 8:00 p.m.
