- Inspection Report from a certified propane fitter confirming compliance to Technical Safety Standards and Safety Act (if equipped with propane-fueled appliances).
- Confirmation from the Province of location approval (if located on a Provincial Highway).

4. Fees

- Non-Refundable fee of \$150.00 to be provided with Application.

Note: There is fee of \$150.00 to be paid upon approval and annually thereafter to remain in operation. There is also a fee of \$40.00 to be paid upon removal of Refreshment Vehicle.

Declaration

I am the Refreshment Vehicle owner/operator named in the above application and I certify the truth of all statements and representations contained herein.

I am aware of all applicable Township of North Frontenac By-laws and will comply with the requirements set-out within.

I acknowledge that I am responsible for ensuring garbage or litter resulting from my vending activity is collected for recycling and disposal, and shall provide receptacles for such purpose, In addition, every Licence Holder shall ensure that such garbage and litter is removed from the area of operation and disposed of at an approved waste site.

I acknowledge that all signage to advertise the location of the Refreshment Vehicle shall comply with all applicable By-laws and the appropriate road authority.

I acknowledge that no structure, whether attached or unattached, is permitted to be constructed immediately adjacent to a Refreshment Vehicle, excluding an unattached deck. The deck shall be less than 0.6 metres in height; less than 10 square metres in area; and does not extend beyond or wrap around the Refreshment Vehicle.

I acknowledge that the Licence shall be affixed to the vehicle in a prominent position.

I acknowledge that upon expiry of the Licence, the Refreshment Vehicle is to be removed from the site.

I further acknowledge that in the event the Licence is revoked by the Township for any cause, irregularity or non-conformity with the Refreshment Vehicle By-law or other Township By-laws and/or Policies, there shall be no right of claim whatsoever against The Corporation of the Township of North Frontenac or any Official thereof and any such claim is hereby expressly waived.
